



PRELIMINARY RESULTS OF THE KICK-OFF MEETING



JUNE 27-29TH, 2016. BRASÍLIA-DF, BRAZIL










THE KICK OFF MEETING IN BRASÍLIA HAD 716 PARTICIPANTS AND WAS THE BIGGEST EVER


The vast majority of participants were Brazilians with 85% and 15% were foreign participants. Among Brazilians, more than half (53%) were from the Federal District and 47% from other states





INSTITUTIONAL REPRESENTATIVITY IN THE KICK OFF MEETING

The highest institutional participation in the event was from public institutions with 42%, followed by civil society organizations with 30%. The lowest representation was from financial institutions with only 3%

60 countries attended the event, including representatives of the embassies representing more than 30 countries



PRELIMINARY RESULTS OF THE THEMATIC PROCESS





The results of the thematic process are still very preliminary as yet has not an indepth analysis of all the material. The coordinator of the Commission shared the following initial impressions:

- Overall the proposed theme was well accepted by the participants
- The main aspects that emerged in discussions are: participation of stakeholders, communication, sharing of best practices and technologies, water security, sustainable water infrastructure, systemic approaches, information management and financing.
- Maximum number of topics must be 30



PRELIMINARY RESULTS OF THE THEMATIC PROCESS

1. CLIMATE - Water security and climate change

(SDG links: SDG 13, SDG 11.5, COP 21-22, Sendai DRR Summit)

- a. Managing risk and uncertainty for resilience and **disaster** preparedness *IR 1.3*
- b. Water and **adaptation** to climate change
- c. Water and climate change **mitigation**
- d. Climate science and water management: the **communication** between science and decision/policy making

2. PEOPLE - Water, sanitation and health

PRELIMINARY RESULTS OF THE POLITICAL PROCESS



Political process will work in three governance levels or sub-processes:

- 1. Governments
- 2. Parliament
- 3. Government / sub-national authorities (including municipalities)

Thus, the main points that were discussed:

- Need for integration between these three sub-processes
- Focus on ODS that relate to water (not just the 6)
- particular attention to climate change adaptation
- high level panels
- Budapest Water Summit as formulation framework and improvement of the political process
- Creation of a parliamentary global network of water
- Strengthening of municipalities and training
- Importance of citizen participation



PRELIMINARY RESULTS OF THE CITIZEN FORUM




The Citizen Forum Process had as main points discussed:

- Need of integration between Citizen and Policy Forums so that there is no historical segregation between popular will and political decision.
- Creation during the Forum of the People's Assembly, in which politicians and heads of state go to the armchair and civil society goes to the stage and make their presentations and suggestions.
- Consider "basins based" processes, habits, concepts, mobilization and cultures. And with respect of the basins as donors and recipients.
- Presentation of explanatory videos on the World Water Forum and its importance in movie theaters across the country and internationally.
- Create a Citizen Portal with information, assistance and research space
- Develop integrated communication plan with the "Road to Brasilia" to dialogue with different audiences




PRELIMINARY RESULTS OF THE SUSTAINABILITY PROCESS

- 1. **Political legacy:** statement or other instrument that creates commitment to the issue, post-event.
- 2. Footprint reduction: participants made many suggestions ex. use of recyclable bins, calculating the water footprint of the Forum, carbon offsetting Forum, etc.
- **3. Sharing and engagement:** creating physical and virtual spaces for sharing experiences (use of Information Technology) and broaden the range of local participation and engagement.
- 4. Technical recommendations: guide with recommendations on sustainability, focusing on SDGs. Need for training and involvement of actors / society.
- 5. Central sustainability themes: risk and resilience (eg climate change.); governance; water security and quality of services; indicators monitoring & evaluation; ecosystem vision X utility water; short X long-term solutions; incentives for sustainability X economic interests; social participation.

PRELIMINARY RESULTS OF THE REGIONAL PROCESS



Regional process had as main points discussed:

- The six regions are vast and complex but there are already pre-set dialogue platforms which will facilitate the work
- Each regional network should have a clear process of identifying priority regional issues (eg. Water Scarcity)
- The consultation process within and across regions should be very broad and inclusive to engage the largest number of stakeholders as possible.
- To achieve this objective the following actions are necessary:
 - Promote regional sessions
 - Promote regional dialogue and sub-regional
 - The format should be inclusive and "bottom-up"
- Discussions should consider vocations, vulnerabilities, solutions, recommendations, restrictions and incentives of all kinds, discussed and agreed upon by all stakeholders and incorporated into solutions.
- Training will be important considering the differences in local capacity between regions
- Interconnection between Thematic and Regional
